I hereby obtain bail for the release of a defendant through Gorilla Bail Bonds, LLC and/or Nation Wide Bail Bonds, LLC under the following TERMS:

- A. The defendant appearing in court each and every time they are so ordered.
- B. Payments of court cost for non-appearance or if the defendant fails to follow any/all instructions or should the court forfeit the bond.
- C. Payment of unpaid premium if the defendant fails or is unable to pay.
- D. If it becomes necessary to apprehend and surrender the defendant to the court and all expenses incurred as a result of such forfeiture.
- E. If a forfeiture occurs, I give to ALL representatives of Gorilla Bail Bonds, LLC and/or Nation Wide Bail Bonds, LLC the right to search any residence of mine or place of residence known to be occupied by me for said defendant, and if defendant is not surrendered within the time prescribed by law, I will pay the full amount of bond, including unpaid premium, attorney fees, court cost, interest, bail recovery/enforcement cost and associated investigation fees.
- F. Collateral will be returned (during normal business hours) seven business days after Gorilla Bail Bonds, LLC and/or Nation Wide Bail Bonds, LLC receives notice from the court, verifying exoneration of the bond. All written obligations/agreements must be satisfied prior to the return of collateral. Collateral will not be returned if not requested within 180 days of exoneration of the bond.
- G. Gorilla Bail Bonds, LLC and/or Nation Wide Bail Bonds, LLC must be notified within 72 hours of any and all changes of address or telephone number for all cosigners and defendants.
- H. If a forfeiture occurs, I give Gorilla Bail Bonds, LLC and/or Nation Wide Bail Bonds, LLC the right to place a lien on my residence or any other personal or business property that I own or have financial interest in.
- I. Once this bond is executed the "PREMIUM" is not refundable.
